

## Niagara Region Sees Significant Price Increases in the Third Quarter of 2015

*Affordable area house prices attracting an unprecedented number of homebuyers*

**NIAGARA/ST. CATHARINES, October 14, 2015** – The Royal LePage House Price Survey<sup>[1]</sup> released today showed healthy year-over-year median price growth across housing types surveyed in Niagara/St. Catharines. In the third quarter of 2015, the aggregate<sup>[2]</sup> home price in the region grew 7.8 per cent to \$289,277.

Over this period, the median price for bungalows saw significant growth, increasing 11.4 per cent to \$271,446. The median price for two-storey homes also showed healthy year-over-year appreciation, rising 3.6 per cent to \$314,567.

“Home prices in the Niagara/St.Catharines region are drawing buyers from Hamilton, Burlington and the Greater Toronto Area,” said Brad Johnstone, broker of record, Royal LePage Niagara Real Estate Centre. “Young professionals who grew up in the region and moved elsewhere are now moving back with their families and are looking to settle into homes that are larger than they could afford elsewhere.”

Johnstone added, “Investment in residential properties by families of foreign students at Brock University and Niagara College has also helped create a strong seller’s market.”

Nationally, home prices showed moderate to strong year-over-year price increases in most markets in Canada. According to the report, the price of a home in Canada increased 8.0 per cent year-over-year to \$502,643 in the third quarter. The price of a two-storey home rose 9.9 percent year-over-year to \$615,304, and the price of a bungalow increased 6.8 per cent to \$421,757. During the same period, the price of a condominium increased 2.8 per cent to \$338,684.

“Economic slowdowns in energy-dependent markets, most notably in western Canada, have in part been offset by both renewed industrial activity in other parts of the country and the Bank of Canada’s recent interest rate cuts,” said Phil Soper, chief executive officer, Royal LePage. “In line with recent quarters, strong national home price increases are largely being driven by continued double-digit percentage increases in the Greater Toronto Area and Greater Vancouver, where housing affordability is already becoming a growing challenge for many individuals and families.”

“Home ownership remains a bright light amid unsettled investment and savings options in volatile global capital markets. As we lead up to election day, it’s not surprising that all of

the major political parties are acknowledging the housing sector’s prominence as the foundation on which the economy has been built for years, and a critical foundation upon which Canadians can build their savings,” continued Soper.

Beginning this quarter, Royal LePage’s House Price Survey includes the Royal LePage National House Price Composite comprising house values for 53 of the nation’s largest real estate markets through the use of a proprietary, custom-built system that analyzes a housing database containing millions of real estate transactions.
