

Kingston Home Prices See Strong Growth in Fourth Quarter of 2017

Low inventory, healthy employment and outside investors drive price appreciation

KINGSTON, January 10, 2018 – The aggregate price of a home in Kingston continued to see strong growth in the fourth quarter of 2017, increasing 7.0 per cent year-over-year to \$337,607, according to the Royal LePage House Price Survey¹ released today.

When broken out by housing type, the median price of bungalow rose 10.6 per cent year-over-year to \$324,168 in the fourth quarter. During the same period, the median price of a two-storey home increased 8.4 per cent to \$369,896.

“Kingston’s housing market remained strong in 2017, inventory is low and we continue to see multiple offer conditions,” said Bob Armer, area manager, Royal LePage ProAlliance Realty. “New investment in the manufacturing space has brought a host of construction jobs to the region, bolstering already high employment rates and a strong local economy. These factors continue to drive migration into our region, which is putting some upward pressure on prices and drawing down housing supply. However, Kingston continues to have attractive affordability and remains one of the most affordable regions in Ontario.”

Armer also noted that a new demographic has begun to look at Kingston real estate: Toronto investors.

“Our reasonable home prices have attracted investors from the Greater Toronto Area looking at purchasing homes for rental properties,” Armer continued. “To date, we have had approximately 500 new home sales from this buyer demographic, which is much higher than previous years.”

Nationally, Canada’s residential real estate market saw strong, but slowing year-over-year price growth in the fourth quarter of 2017. The Royal LePage National House Price Composite, compiled from proprietary property data in 53 of the nation’s largest real estate markets, showed that the price of a home in Canada increased 10.8 per cent year-over-year to \$626,042 over the three-month period. When broken out by housing type, the median price of a two-storey home rose 11.1 per cent year-over-year to \$741,924, and the median price of a bungalow climbed 7.1 per cent to \$522,963. During the same period, the median price of a condominium appreciated faster than any other housing type studied, rising 14.3 per cent to \$420,823 on a year-over-year basis.

“To prospective homeowners in our largest cities, condominiums represent the last bastion of affordability,” said Phil Soper, president and CEO, Royal LePage. “This is especially true for first-time buyers whose purchasing power has been reduced by tightening mortgage regulations.”

In line with Royal LePage’s previous [Market Survey Forecast](#), Royal LePage predicts that the price of a home in Canada will increase 4.9 per cent by the end of 2018. Looking ahead, the

company anticipates that the new OSFI stress test will slow the housing market in the first half of 2018, as buyers adjust their expectations and many market participants take a “wait and see” approach.

“The unsustainably high rates of home price appreciation witnessed in recent years in B.C. and Ontario were dangerous to the stability of not only the housing market, but to the broader economy itself,” continued Soper. “Policy measures like the OSFI stress test will quell runaway housing inflation to an extent. However, we do foresee an upswing in demand in the latter portion of the year, as prospective buyers adjust to the new realities. To put it another way, the demand is still there.”
